Supplement Narrative

Dr. FELNER stated a cover note saying, "We will get you one way or the other. Read this. Resign now while you can." was attached to a document sent to DR. RAMSEY & Dr. WILLIHNGANZ concerning his management as Dean of the College of Education and Human Development. Dr. FELNER said that he had found the documents under his door upon his arrival to work on 23 Mar 2006. Dr. FELNER said that several individuals had handled the document. The documents were secured into evidence under Property Record # 1985.

Dr. FELNER said that after a faculty meeting on 3 Mar 2006 he had discovered that someone had poured coke over his parked car.

Dr. FELNER advised that he was requested to report the matter by Ms. Angela KOSHEWA but he understood that the next logical step in the investigation would be to interview individuals within the school that may have sent the document. Dr. FELNER said that he knew of six to eight individuals off the top of his head that may have sent the document but he felt that the interview process would cause more disruption than help solve the issue. Dr. FELNER discussed the possibility of installing a surveillance camera system in the building to help with several security related issues and he advised he might pursue that issue with his staff. It was suggested that Dr. FELNER contact this officer the next faculty meeting in order to watch his vehicle.

Dr. FELNER said that for the time being he just wanted to report the incident and wanted no further action taken at this time.
